

AutoCAD LT New Seat Rebate Promotion

Full Terms and Conditions

ANZ Final (18 October 2011)

This rebate program is sponsored by Autodesk Australia Pty Limited (ACN 006 741 340). The promotional campaign and rebate redemption settlements are managed by Arvato Digital Services Pte Ltd, located in Singapore (“arvato”).

Through this program, the rebate will be paid by arvato after the purchase and independently from the original purchase price. Independent distributors or resellers of Autodesk products are not bound by this program and remain free to determine their own sales prices.

The AutoCAD LT® New Seat Rebate Promotion is valid only with purchases of qualifying new commercial licenses of AutoCAD LT® 2012 software. Upgrades from current or non-current versions, crossgrades, educational licenses, government licenses, education-to-commercial or government-to-commercial transfers DO NOT qualify.

End-users that purchase a full commercial license of AutoCAD® LT 2012 software (the above exclusions apply) between November 1st 2011 and January 13th 2012 (dates inclusive), and submit a valid rebate redemption request within 30 days from date of purchase and January 27th 2012 at the latest, may qualify for a refund of up to AUD 200.00 or NZD 200.00 based on the end-user’s country of residence, irrespective of the original purchase price.

This promotion is valid in Australia and New Zealand only. Only companies established in Australia or New Zealand and individuals resident in Australia or New Zealand qualify for redemption of this promotion.

The rebate can only be claimed by completing Autodesk end user registration or product activation and the online rebate form at www.autodeskrebate.com/apac with the relevant product purchase information including purchaser’s personal and company details, the Autodesk part number of the product licenses, serial number from the AutoCAD LT® software and quantity of licenses purchased. In addition, submission of a legible copy of the end-user’s original invoice or sales receipt dated from between November 1st 2011 and January 13th 2012 (dates are inclusive), including a description of the product licenses purchased, Autodesk part number and serial number of the product licenses purchased, quantity of licenses purchased, and the reseller name. The purchaser’s personal and company details indicated on the original invoice or sales receipt must match the personal and company details provided in the online rebate form at www.autodeskrebate.com/apac. Any information on purchase prices obtained by arvato will not be accessed by Autodesk. Incomplete, incorrect or missing information will cause the submission to be disqualified. Purchase orders will not be accepted as proof of purchase.

To apply for a rebate, the end-users will be asked to provide personal information, including bank account information, to Autodesk and to consent to the usage of such information for the purpose of

facilitating payment. Autodesk may share this information with arvato and other third parties (eg banks) for the purpose of paying the applicable rebate. The rebate may not be made to the end-users if the requested personal information is not provided or provided without the end-users' consent. The collection, use and storage of your personal information will be governed by Autodesk's privacy policy at <http://usa.autodesk.com/privacy/>.

The rebate will be paid out by arvato via bank transfer or cheque for deposit only. The currency of the pay-out or check will be in AUD or NZD as applicable based on the location of the recipient. PAYMENT WILL ONLY BE MADE TO BANK ACCOUNTS IN THE NAME OF THE PURCHASER; NO PAYMENT WILL BE MADE TO ANY THIRD PARTIES. Bank fees and charges applicable to bank transfers, check deposits and currency conversions may be deducted from the rebate value by the recipient's bank. Bank transfers will be made only to Australian and New Zealand companies or residents, and only to bank accounts with banks in Australia or New Zealand, as applicable. The rebate value cannot be applied towards future purchases.

Autodesk channel partners, resellers, distributors and purchasing agents may not submit claims on behalf of the end user customer. This promotion is not valid for product licenses purchased through the Autodesk Employee Purchase Program.

The rebate will be paid out by a third party selected by arvato via bank transfer or cheque for deposit only. The final pay-out amount received by the end user may vary slightly depending on local bank fees and charges for check processing, direct payments, foreign currency conversion or similar.
